EXPLANATORY STATEMENT*(Pursuant to Section 102(1) of the Companies Act, 2013 and Secretarial Standard II on General Meetings)***ITEM NO. 1****TO INCREASE THE AUTHORIZED SHARE CAPITAL OF THE COMPANY AND MAKE CONSEQUENT ALTERATION IN CLAUSE V OF THE MEMORANDUM OF ASSOCIATION: SPECIAL RESOLUTION**

In order to broad base capital structure of the Company and to enable the Company to issue further shares, it is proposed to increase the authorized share capital of the Company from existing Rs. 12,00,00,000/- (Rupees Twelve Crore Only) divided into 1,20,00,000 (One Crore Twenty Lakh) Equity Shares of Rs. 10/- (Rupees Ten Only) each to Rs. 15,00,00,000/- (Rupees Fifteen Crore Only) divided into 1,50,00,000 (One Crore Fifty Lakh) Equity Shares of Rs. 10/- (Rupees Ten Only) each, by way of creation of an additional 30,00,000 (Thirty Lakh) Equity Shares of Rs. 10.00 (Rupees Ten only) each, ranking pari-passu in all respect with existing equity shares of the company, aggregating to Rs. 3,00,00,000 (Rupees Three Crore only).
